## Rules & Regulations

### Little Miss & Miss Merry Christmas Pageant

This Year's Pageants Will Be Held on Friday, December 9, 2011  
At Star Elementary School At 7:00 pm.

- The Halcyon Woman's Club, pageant committee, or the place where the event is held is NOT responsible for any accidents, injuries, or theft that may occur before, during or after the event.
- Pageant director and committee have the right to refuse any application for any reason.
- REFUNDS will NOT be refunded for any reason to anyone.
- Judges decisions are final and should not be approached for any reason at anytime other than by pageant director or a committee member.
- Miss Merry contestants should not be married, or have been married, or plan to marry during her reigning year. Nor should she have a child or become pregnant during her reign. If either takes place, the 1<sup>st</sup> runner-up will be crowned.
- All attire must be age appropriate and in good taste.
- Parents, contestants and their guest should conduct themselves in a respectful and orderly manner at all times.
- Poor sportsmanship will NOT be tolerated and will result in disqualification of contestant.
- The new "Little Miss" and "Miss Merry Christmas" queens will be REQUIRED to represent the Halcyon Woman's Club in the following events:
  - **Star Fiddlers Convention**
  - **Troy's 4<sup>th</sup> of July Parade**
  - **Candor Peach Festival Parade**
  - **Attend the Denton Lion's Club Pageant as a Visiting Queen**
  - **Star Christmas Parade**
- The new "Little Miss" or "Miss" queens will NOT be allowed to enter any other pageants during their respective reigns as "Little Miss" or "Miss" Merry Christmas. They may represent the Halcyon Woman's Club at any pageant or event other than those listed above as a "visiting queen".

- Entry fee: **\$30.00** (Contestants may have a business, club, or family to sponsor them in the pageant.) There will be a \$30.00 charge on all returned checks.
- **“Little Miss” Contestants**
  - Must be in kindergarten or 1<sup>st</sup> grade
  - Must live in Montgomery County
  - Must attend a Montgomery County School or be home-schooled based in the county.
- **“Miss Merry” Contestants**
  - Must be in grades 10, 11 or 12<sup>th</sup>
  - Must live in Montgomery County
  - Must attend a Montgomery County School or be home-schooled based in the county.
- Each contestant will be placed in the pageant by alphabetical order.
- Winners of the Pageants on Friday night will ride through the Star Christmas Parade on the Halcyon Woman’s Club float. Dressing warmly is both appropriate and recommended. Contestants will need to be in the parade line-up by 12:45pm. Line-up information will be given out at the conclusion of rehearsal. Also, all other contestants are welcomed to ride in the parade; but will have to provide their transportation.
- Rehearsal will be held at Star Elementary School Auditorium on **Thursday, December 8, 2011**. All contestants (“Little Miss” and “Miss”) should be there **@ 6:00pm**. All contestants will be in ONE pageant.
- Each contestant will be required to answer an unrehearsed interview question during the pageant (Live on-stage).
- **All parents and contestants** must sign that they have read the RULES & REGULATIONS and have acknowledged this by signing the application.
- Deadline: **Wednesday, November 23, 2011....day before THANKSGIVING!!!!**
